Deposit of 2022-2023 Financial Statements

Whereas the audit firm BCGO S.E.N.C.R.L. was appointed as the auditors for the New Frontiers School Board (NFSB) for the 2022-2023 fiscal school year; and whereas on revenues of \$92,153,726 and expenses of \$83,900,304 the New Frontiers School Board recorded a surplus of \$8,253,422 for the year ended June 30, 2023; and whereas under the accounting policy of the Ministry of Education, the excess of revenues over expenses is allocated to the accumulated deficit, if any; and whereas commissioners will be provided with extracts of the comparative financial statements including the School Board's Balance Sheet, Income Statement, and Statement of Accumulated Surplus; and whereas the schedules below summarize the results of operations and the effect upon the School Board's accumulated deficit.

Resolution #CC23-12-05-002

Approval of the List for Non-Payment of School Tax

Appointment of New Frontiers School Board Representative

Whereas, notwithstanding the New Frontiers School Board's (NFSB) protocols for sending repeated notices and reminders to property owners of taxable immovable property for payment of school tax to NFSB, there are still owners each year that remain in default of payment of school taxes; and whereas, according to article 339 of the Education Act of Quebec, we must prepare, before the beginning of November each year, the list of owners with taxes due on buildings which may be put up for sale for non-payment of school taxes; and whereas provisions within the Education Act, the Cities & Towns Act, and the Municipal Code of Quebec, provide that these statements of unpaid school taxes be approved by the Council of Commissioners; and whereas it is in the interest of the NFSB, when deemed necessary, to ask the municipalities of our territory, to register NFSB as a creditor in the sale for non-payment of taxes, on the taxable immovables described in the approved statement of unpaid school taxes; and whereas it is necessary to appoint a representative of the NFSB in connection with any sale of buildings for non-payment of school taxes to the Regional County Municipalities of our territory;

Therefore, on the recommendation of the Operations Standing Committee, it was moved by Commissioner D. McKell Eastwood that the Council of Commissioners of the New Frontiers School Board approve the statement of unpaid taxes; and that Terence Savoie, Director of Financial Resources, be appointed as the representative of the New Frontiers School Board in connection with any sale of buildings for non-payment of school taxes.

Whereas Bill 96, An Act respecting French, the official and common language of Québec, was assented to on June 1,

2022; and whereas the same day the English Montreal School Board brought an application to challenge the constitutionality of numerous provisions of Bill 96 and the Charter of the French Language; and whereas the English Montreal School Board's constitutional challenge to Bill 96 has been joined with the constitutional challenges of other parties and is progressing through the court system though, like all constitutional challenges, it is expected to be a lengthy process; and whereas amendments to the Charter of the French Language that came into force on June 1, 2023 would require that English language school boards communicate with key institutions of the English-speaking community, such as the Quebec English School Boards Association, in French exclusively; and whereas on September 29, 2023, the Office québécois de la langue française provided the English Montreal School Board with an interpretation of provisions of Bill 96 and the Charter of the French Language, which would effectively require that most internal written communications at the English Montreal School Board be conducted in French; and whereas such an interpretation would also require that most written communications between commissioners of English-language school boards be conducted in French; and whereas the Québec Court of Appeal in its decision on the stay of Bill 40 recently reaffirmed that section 23 of the Canadian Charter prevents the

province from interfering "with the linguistic and cultural concerns of the minority"; and whereas implementing provisions of Bill 96 and the Charter of the French Language, as interpreted by the Office québécois de la langue française, would fundamentally alter the linguistic culture; and whereas implementing provisions of Bill 96 and the Charter of the

French Language, as interpreted by the Office québécois de la langue française, would detract from the needs and priorities of the nine English language school boards, their students, parents and the broader community it serves; and whereas all of these effects would lead to irreparable harm for the English-language community; and whereas the Quebec English School Boards Association and all nine English school boards obtained a stay of Bill 40 in 2020, which was confirmed by the Québec Court of Appeal, based on the irreparable harm that implementing Bill 40 would cause to the English-speaking community, while waiting for a decision on the merits of the challenge;

Therefore, it was moved by Commissioner J. Largan that the New Frontiers School Board become an intervenor in the constitutional challenge put forward by the English Montreal School Board; and that the New Frontiers School Board Council of Commissioners mandate the legal firm, Power Law, to institute on its behalf the appropriate legal proceeding.

Authorization of the Sale of Ro-Bus Inc.

Whereas Mr Robert L. Auger, President of Ro-bus Inc., has informed the New Frontiers School Board that Ro-Bus Inc. intends to transfer the ownership of its shares (via sale) to Transdev Canada Inc. and/or one of its wholly-owned subsidiaries; and whereas no contracts will be assigned or transferred as part of the transaction; and whereas our transportation contracts require the New Frontiers School Board to consent to the transaction; and whereas consent form(s) has been submitted by Ro-Bus Inc. for signature; and whereas a sale requires a motion approved by the Council of Commissioners; and whereas Ro-Bus Inc. has contracts for 11 regular and seven mini-buses which are used for transportation services with the New Frontiers School Board; and whereas no additional cost will be incurred by the New Frontiers School Board with respect to this transfer of ownership of shares of Ro-Bus Inc.;

Therefore, on the recommendation of the Educational Services Standing Committee, it was moved by Commissioner C. Stacey that the Council of Commissioners approve the transfer through sale of shares of Ro-Bus Inc. to Transdev Canada Inc. and/or one of its wholly-owned subsidiaries; and that the Director of Educational Services of the New Frontiers School Board be authorized to sign the consent form(s) and any other relevant documentation to authorize this transaction.

Whereas Mr Robert L. Auger, President of Ro-bus Inc., has informed the New Frontiers School Board that Ro-Bus Inc. intends to transfer the ownership of its shares (via sale) to Transdev Canada Inc. and/or one of its wholly-owned subsidiaries; and whereas no contracts will be assigned or transferred as part of the transaction; and whereas our transportation contracts require the New Frontiers School Board to consent to the transaction; and whereas consent form(s) has been submitted by Ro-Bus Inc. for signature; and whereas a sale requires a motion approved by the Council of Commissioners; and whereas Ro-Bus Inc. has contracts for 11 regular and seven mini-buses which are used for transportation services with the New Frontiers School Board; and whereas no additional cost will be incurred by the New Frontiers School Board with respect to this transfer of ownership of shares of Ro-Bus Inc.;

Therefore, on the recommendation of the Educational Services Standing Committee, it was moved by Commissioner C. Stacey that the Council of Commissioners approve the transfer through sale of shares of Ro-Bus Inc. to Transdev Canada Inc. and/or one of its wholly-owned subsidiaries; and that the Director General of the New Frontiers School Board be authorized to sign the consent form(s) and any other relevant documentation to authorize this transaction.
