Adoption of Policy EH "Information Security & Privacy"

Whereas the Act respecting Access to documents held by public bodies and the Protection of Personal Information ("ARA"), the Act respecting the governance and management of the information resources of public bodies and government enterprises, and the Directive gouvernementale sur la sécurité de l'information imposed obligations on educational institutions in their capacity as public bodies; and whereas the New Frontiers School Board's current Policy EF "Information Security" required updating to be in compliance with the aforementioned acts and directive; and whereas, on February 6, 2024, Policy EF was referred to the Law 25 Information Security Committee, chaired by the Secretary General, to undertake said updating; and whereas the revised Policy EF underwent a formal consultation process; and whereas it is recommended that the coding of this policy be changed from EF to EH;

Therefore, on the recommendation of the Law 25 Information Security Committee, it was moved by Commissioner B. Ednie that Policy EH "Information Security & Privacy" be adopted as presented.

Recommendations from the Resource Allocation Committee

Whereas the 2023-2024 Resource Allocation Committee (RAC) has met during the year to consult on the objectives, principles, and procedures used in the preparation of the School Board's annual budget; and whereas the 2023-2024 RAC is making the following recommendations to the Council of Commissioners for the 2024-2025 school year:

Operational and Educational Capital Budgets - Youth Sector

- Increase operational allocations by 3%.
- Increase capital allocations by 3%.

Holdbacks

Withhold 8% on Measures 15011, 15015, 15025 same methods as previous year, with the following conditions:

- Financial Services provides a detailed account to RAC in 2024-2025.
- Finance will ensure to email all principals a reminder of the process.
- Initial requests reviewed by RAC at their first meeting of 2024-2025.
- 100% replacement for sick leave with re-evaluation in December/January 2024-2025.
- Measure 15312 will now be managed centrally and provide external consulting services to each school.

Four-Year-Old Kindergarten

Centralize management of Measure 11023, same as previous year.

Daycare Chargebacks

Increase from 4% to 8% for 2024-2025.

Measure 15313 – Learning Centres

Use to support the overall needs of the system but allocate and track at Howard S. Billings High School, same as previous year, to accommodate the reporting of the measure usage.

Measure 15333 – Support to Students with Ministry Codes

Hire an Inclusive Education Consultant (special needs), same as in the previous year; managed centrally, shared by all schools.

All remaining Youth Measures

All new protected or dedicated measures be allocated using the funding method of the Ministry of Education for the school board.

Protected & Dedicated Measures - Adult Sector

That all Adult measures be allocated using the enrollment as consulted on with the adult sector. Fixed allocations will be used with some measures to support smaller centres.

School Surpluses

In accordance with Article 193.4 of the Education Act, the Resource Allocation Committee recommends that all surpluses go towards the school operations and Ed capital budget and are part of the 3% increase for 2024-2025.

Therefore it was moved by Commissioner P. Stuckey that the Council of Commissioners accept the recommendations made by the 2023-2024 Resource Allocation Committee for the 2024-2025 school year.

The Director General presented his report, which will be available in the Governance folder. Whereas negotiations have been concluded with the Chateauguay Valley Teachers' Association on the establishment of the 2024-2025 school calendar for the Adult General Education sector; and whereas the proposed 2024-2025 calendar provides for two hundred (200) working days for teachers, between July 1, 2024 and June 30, 2025; and whereas the proposed calendar provides for a Christmas break to extend from December 23, 2024 to January 3, 2025, inclusively; and whereas the proposed calendar provides for a March break to extend from March 3 to March 7, 2025, inclusively for the adult education sector;

Therefore, on the recommendation of the Educational Services Standing Committee, it was moved by Commissioner K. Van Droffelaar that the Council of Commissioners approves the 2024-2025 school calendar for the Adult General Education sector, as presented.

Vocational Education Calendar 2024-2025

Whereas negotiations have been concluded with the Chateauguay Valley Teachers' Association on the establishment of the 2024-2025 school calendar for the Vocational Education sector; and whereas the proposed 2024-2025 calendar provides for two hundred (200) working days for teachers, between July 1, 2024 and June 30, 2025; and whereas the proposed calendar provides for a Christmas break to extend from December 23, 2024 to January 3, 2025, inclusively; Therefore, on the recommendation of the Educational Services Standing Committee, it was moved by Commissioner K. Van Droffelaar that the Council of Commissioners approves the 2024-2025 school calendar for the Vocational Education sector, as presented.
