Commissioner Stipends

Whereas the current total stipend allocation for commissioners is \$133,103; and whereas this amount must be completely distributed amongst commissioners; and whereas there has been some indexation to the amounts allocated since 2020;

Therefore, on the recommendation of the Executive Committee, it was moved by Commissioner J. Largan that commissioner stipend amounts be confirmed as follows: Commissioner, \$8,126.56; Executive Committee member, \$8,254.75; Vice-Chair, \$12,377.00; and Chair, \$14,439.76; and that any indexation amounts continue to be applied to the four salary amounts equally.

Naming of Complaints Officer (Responsable du traitement des plaintes)

Whereas By-Law JCEA identifies a "Complaints Officer" who is designated by the School Board; and whereas Article 24 of Bill 9 "An Act Respecting the National Student Ombudsman", also identifies that an employee be designated by the Council of Commissioners as the "Responsable du traitement des plaintes" (RTP); and whereas Luisa Benvenuti has been serving in this capacity since her naming by the Council of Commissioners on September 5, 2023; and whereas it is proposed that another employee be named in this capacity effective July 1, 2024;

Therefore, on the recommendation of the Executive Committee, it was moved by Commissioner L. Chouinard that the Council of Commissioners designate Me Linda Julien as the "Complaints Officer" (Responsable du traitement des plaintes) for the New Frontiers School Board, effective July 1, 2024.

Remuneration Rates for Election Personnel for School Elections 2024

Whereas Article 30 of the Act Respecting School Elections to elect certain members of the Board of Directors of English-Language School Service Centres stipulates that the School Board shall fix the tariff of remuneration and expenses of election personnel; and whereas said tariffs cannot exceed the tariffs fixed under said Election Act;

Therefore, it was moved by Commissioner L. Ferguson that the New Frontiers School Board engage election personnel as required to run the school elections of November 3, 2024; and that said elections personnel be remunerated in accordance with the "Tables des taux et modalités de rémunération du personnel électoral" provided by Elections Québec.

Special Needs Advisory Committee 2023-2024 Annual Report

Whereas, in accordance with Policy IHBA, the vision of the New Frontiers School Board (NFSB) is to motivate its students to become lifelong learners and to empower them to become responsible, contributing members of society, applying their knowledge in order to adapt to a diverse and changing world; and whereas, to ensure educational success for everyone, the NFSB provides and organizes a range of special needs services which include preventative measures, early intervention initiatives, integration support services, and special education services; and whereas the Annual Special Needs Report is intended to provide information to all stakeholders and is developed and provided annually by the principal of each school, in consultation with the staff concerned; and whereas the Special Needs Advisory Committee (SNAC) makes recommendations to the Council of Commissioners; and whereas the final reports and the SNAC recommendations are assembled into the Annual Special Needs Report and deposited with the Council of Commissioners; and whereas the Educational Services Standing Committee has received and reviewed the Annual Special Needs Report, including the SNAC recommendations, describing the services offered to students with special needs within NFSB schools;

Transportation Service Agreement with Riverside School Board 2024-2025 School Year

Whereas, at their meeting of June 18, 2024, the Transportation Advisory Committee discussed a proposed transportation service agreement with Riverside School Board (RSB); and whereas, at their meeting of June 18, 2024, the Educational Services Standing Committee discussed a proposed transportation service agreement with RSB; and whereas the agreement would be for students who reside on the territory of the New Frontiers School Board (NFSB) and attend Reach School, which has superregional status; and whereas the NFSB-zoned students attending Reach receive other services, including complementary, from the RSB; and whereas the agreement would facilitate the organization of transportation services provided to NFSB-zoned students, including the evaluation and implementation of support measures, and communications between home and school; and whereas the RSB would invoice the NFSB for the delivery of these services rather than the NFSB providing the services directly;

Therefore, on the recommendation of the Educational Services Standing Committee, it was moved by Commissioner C. Stacey that the New Frontiers School Board enter into an agreement with the Riverside School Board to provide transportation services to Reach school for NFSB-zoned students for the 2024-2025 school year; and that the Director responsible for Transportation be authorized to sign said agreement.
