Call to Order & Opening Remarks

The Director General opened this 350th meeting at 18:15 hours and welcomed members.

Confirmation of Compliance - Calling of a Special Meeting

The Director General confirmed that this special meeting was called in conformity with the requirements of the Education Act.

Recognition Statement

K. An election was organized in Electoral Division #6. "Notice of Election" cards were mailed to all registered voters in Division #6, and a public notice was issued on October 4, 2024, indicating that the electoral list for Division #6 would be revised, with electors provided with two opportunities to have their names added, removed, or corrected:

A second public notice of polling was issued on October 18, 2024, and "Voting Reminder" cards were mailed to all registered voters, including those added following the revision process.

Itinerant voting was offered to 19 registered long-term health care facilities; no requests for itinerant voting were received.

Polling stations were set up at Gault Institute for electors living in Salaberry-de-Valleyfield, and at Mary Gardner School for electors living in Beauharnois and St-Etienne-de Beauharnois. An advance poll was held on Sunday, October 27, 2024. 17 electors voted in the advance poll at Gault Institute; nobody voted at Mary Gardner School on that day. Polling day took place on November 3, 2024, in these same locations. 30 electors voted at Gault Institute and 14 electors voted at Mary Gardner School. With a total of 61 voters, out of 1430 registered voters, the voter turnout rate for New Frontiers is 4.3%.

Following the closing of the polls on Sunday, November 3, 2024, ballots were counted at the offices of the New Frontiers School Board. Results were 22 votes in favour of Corrine Kane and 39 votes in favour of Anne-Marie Yelle. Therefore, Anne-Marie Yelle was declared elected by majority vote in Electoral Division #6.

As there was no request for a judicial recount within the four days following the Election, I declare that the November 3, 2024 elections for the New Frontiers School Board are hereby closed, with the following results:

Naming of Complaints Officer

Whereas By-Law JCEA identifies a "Complaints Officer" who is designated by the School Board; and whereas Article 24 of Bill 9 "An Act Respecting the National Student Ombudsman", also identifies that an employee be designated by the Council of Commissioners as the "Responsable du traitement des plaintes" (RTP); and whereas Me Linda Julien has been serving in this capacity since July 1, 2024; and whereas it is proposed that another employee be named in this capacity effective November 30, 2024;

Resolution #CC24-11-19-003

Naming of Officer Responsible for the Management of Ethics and Integrity

Whereas all of the provisions of Bill 53 (the Act to enact the Act respecting protection against reprisals related to the disclosure of wrongdoings and to amend other legislative provisions (SQ 2024, c.21)) will come into effect on November 30, 2024; and whereas public organizations must take certain actions by November 30, 2024, including repealing existing internal procedures with respect to the disclosure of wrongdoings and the abolishment of the position of Disclosure Officer and naming an Officer Responsible for the Management of Ethics and Integrity;

Therefore, on the recommendation of the Director General, it was moved by Commissioner L. Ferguson that the Council of Commissioners designate Sabrina De Castris as the "Officer Responsible for the Management of Ethics and Integrity" (Responsable de la gestion de l'éthique et de l'intégrité) for the New Frontiers School Board, effective November 30, 2024.

Resolution #CC24-11-19-004

Association Fees – "Association Réseau du Sport Étudiant du Québec (RSEQ)"

Whereas the Réseau du Sport Étudiant du Québec (RSEQ) is the governing body of primary and secondary school, collegiate and university sport in Quebec; and whereas the New Frontiers School Board has been affiliated with RSEQ Montérégie for many years; and whereas the New Frontiers School Board would like to renew the affiliation for the upcoming year; and whereas the Council of Commissioners is required to adopt a motion confirming our sports affiliation with RSEQ Montérégie for the 2024-2025 school year;

Therefore, on the recommendation of the Educational Services Standing Committee, it was moved by Commissioner K. Van Droffelaar that the New Frontiers School Board pay to l'Association RSEQ Montérégie:

- A base affiliation fee of \$405.08; and
- A per capita membership rate of twenty-eight cents per student (\$0.28) at the elementary level; and
- A per capita membership rate of twenty-nine cents per student (\$0.29) at the secondary level; and

That these fees be based on the September 30, 2024, enrolments in all our schools; and that Terri Marino (secondary level) and Christopher Blouin (elementary level) be designated as the School Board's representatives to the RSEQ.
